Marilyn Sanders provided an overview of the application for the redesignation of 15.00 acres \pm described as a portion of Plan 912-3235, Block 1, Lot 1, PT SE 24-39-08-W5 from Country Residence Minor Industrial District "CRMI" to Country Residence Agriculture District "CRA" for the purpose of consolidating the land with Plan 102-5940, Block 3, Lot 8.

Ms. Sanders noted the subject lands, located approximately 5 miles west of the Town of Rocky Mountain House on Old Highway #11A, fall within the Ferrier-Garth Area Structure Plan and provides direction for the development of SE 24-39-08-W5.

A recent amendment to the ASP under Bylaw 949/11 adopted November 29, 2011 amended the long term direction of the Ferrier-Garth Area Structure Plan as it relates to this land. The amendment allows the westerly 15 acres to be considered for future Country Residence Agriculture District "CRA" development.
