B-i. ELECTION OF REEVE AND OFFICIAL OATH (Reeve will then take the chair)

Background: Section 150 (2) of the Municipal Government Act states that the chief elected official of a municipality is to be appointed by council from among the councilors' unless the council passes a bylaw providing that the official is to be elected by a vote of the electors of the municipality. No By-law has been passed.

Recommendation:

That the Council conduct an election for the purpose of electing a Reeve in accordance with the following process:

- a) The Manager will conduct the election for Reeve.
- b) The Manager will call for nominations three times for the position of Reeve. It will not be necessary for seconders for any nominations.
- c) A motion will be required for nominations to cease.
- d) In the event there is more than one nomination, voting will be done by ballot.
- e) The ballots will be counted by the Manager and one other staff.
- f) The Manager will announce the person elected as Reeve but will not disclose the vote count.
- g) In the event of a tie vote the Manager will place the names in a "Hat" and draws one name that shall be declared the winner of the election. Again, the Manager will not disclose there was a tie vote.
- h) Immediately after the announcement of the election results a motion will be required to destroy the ballots. As well, the Municipal Government Act requires Council to pass a resolution to confirm the secret ballot.
- i) After the declaration of the Reeve, the Chair will be turned over to the Reeve.

B-ii. ELECTION OF DEPUTY REEVE AND OFFICIAL OATH

Background: The Municipal Government Act, Section 152 (1) states that a council must appoint one or more councilors' as deputy chief elected official so that:

- a) Only one councilor will hold that office at any one time, and
- b) The office will be filled at all times.

Recommendation:

A similar procedure will be followed as in the previous election except that the newly elected Reeve will call for nominations and the required motions. The Manager and staff member will count ballots and announce the results.

C. SIGNING AUTHORITY

Present Policy: That the Reeve, Deputy Reeve, Municipal Manager, Acting -Manager or the Corporate Services Manager may be the signing authority for the next year.

D. MEETING DATES

Section 193 (1) allows Council to set dates for regular meetings without public notification of each meeting. All Councillors must be at the meeting for setting the day, hour and place.

Present Policy: That regular meetings be held on the 2nd and 4th Tuesdays of each month in the County Office in Rocky Mountain House.

These meetings will be called at the hour of 9 o'clock a.m.






