2. Community Historical Society of Caroline

L. Kirbyson, President, and J. Pearson, Vice-President, Community Historical Society of Caroline, presented a PowerPoint, 'Chedderville Church Move', that explained the Society's plan to relocate the Church to the Caroline Museum grounds.

L. Kirbyson responded to questions and confirmed the Society is planning fundraising initiatives for relocation costs, however the Society asks that Council consider contributing to relocation and building upgrade costs, estimated at \$35,000.00.

It was clarified that Council is not prepared to contribute funds at this time, however Council will consider transferring Church ownership to the Society once the Society raises enough funds to cover relocation and reclamation costs, as per Council's motion at the December 12, 2017 regular meeting.

1. 2018 Fire Season Prevention Report

In 2017, Clearwater Regional Fire Rescue Services (CRFRS) firefighters responded to 80 wildland fires within the County and provided fire services/support to wildfires in British Columbia over a five-week period.

Effective March 1 to October 31, permits are required for burning within the Forest Protection Area (FPA); and, for areas outside of the FPA, notification of burning is required.

During the 2018 Fire Season, CRFRS will monitor conditions and consult with Alberta Forestry on the implementation of fire bans during the upcoming

season. CRFRS will also continue raising awareness on the prevention of grass and wildfires and encourage residents to participate in upcoming FireSmart community events. CRFRS will also work with Burnstick Lake Summer Village to identify high fire hazard areas and work on preparedness plans.

Fire Chief Debienne responded to questions and confirmed Alberta Forestry was invoiced, as per the Mutual Aid Agreement, for services rendered and CRFRS received payment from British Columbia for services.

2. Public Engagement Strategy

At the January 23, 2018 regular meeting, Council motioned to engage the public on a proposed broadband infrastructure project outlined in the Broadband Policy that was approved on February 27, 2018.

Discussion took place on strategies, techniques and, processes to be used for public engagement and the following points were made:

- The purpose of engagement is: to provide information to assist the public in understanding that the current level of broadband/internet service within rural areas does not meet existing economic/social needs; to identify possible solutions for improving broadband/internet service to meet existing and future needs; to educate the public on a general broadband/internet infrastructure concept plan; and, to obtain feedback on issues and proposed solutions.
- Key audiences include County residents and business owners, municipalities and First Nations within the County's borders, industry stakeholders and local internet service providers.
- Key audiences are to be engaged at different levels of public participation as outlined in the 'Spectrum of Public Participation' produced by the International Association of Public Participation.

Discussion continued and suggestions were made on how to conduct several facilitated engagement sessions at different levels of participation and, types of resources, such as speaker presentations/testimonials, that could be used to inform and educate the public on broadband issues and solutions.
