COMMUNITY & PROTECTIVE SERVICES:

1. Delegation: Rocky Mountain House RCMP Detachment Commander, Staff Sgt. Mark Groves

Staff Sgt. Mark Groves provided crime statistics from 2013 to 2016 and noted personal property crimes continue to increase. Successful partnerships with Clearwater County Highway Patrol Officers, provincial agencies, and other RCMP detachments continue to aid enforcement measures.

Staff Sgt. Groves announced the vacant School Resource Officer position is filled. Overall, the Rocky Mountain House Detachment is almost operating with a full staff complement which has improved service for First Nations and the Caroline area.

Sgt. Penner responded to questions and explained response service for Nordegg successfully met objectives for coverage during peak periods.

Discussion took place on rural crime in the area. Staff Sgt. Groves noted the Rural Crime Watch program is developing with intent for improvements. Currently, rural crime activity is mostly related to property theft, unfortunately lack of reporting of stolen property hinders RCMP efforts in property recovery.

Discussion took place on the current backlog in the court system for processing traffic and criminal charges. Staff Sgt. Groves is working with Sgt. Miller, Clearwater County Highway Patrol Officer, to determine a course of action. Staff Sgt. Groves suggested lobby efforts may be beneficial in addressing this issues.

2. Policy Review: Community Hall Capital Grant Funding

Ted Hickey outlined proposed amendments to the *Capital Grant Funding For Community Halls* policy. Amendments provide clarity, emphasize the County's position as 'funder of last resort', and sets procedure for timely budget planning.

Discussion took place on the recommendation to include an administrative appendix to identify dollar values for costs such as labor rates, trade rates, and machinery or equipment rates, based on provincial and/or industry guidelines, to provide context and fairness in relation to "matching component" for County financial contribution.
