## **CAO's REPORT**

## March 12, 2019

1. The Intermunicipal Collaboration Committee (ICC) met on February 28 to discuss several topics regarding regional services for water rescue, economic development, solid waste and a subdivision appeal board. After discussions, the ICC recommended the following: 1. That Town/Village and County Councils consider amending the Intermunicipal Regional Fire and Rescue Service Agreement to include water rescue services; 2. That Administration provide the Committee with information and alternatives for a landfill operating under either: a) a municipal agreement, b) a commission or c) a municipal corporation; 3. That Administration from each municipality provides updates on their respective economic development strategies to Town/Village and County Councils; and, 4. That each Council provides updates on their respective wastewater programs.

The next ICC meeting is scheduled for April 12.
