

**September 11<sup>th</sup>, 2018**

**Public Works Report**

**Gravel Roads**

Graders are continuing their efforts on soft areas, areas with washboards, and areas with potholes.

Patch gravelling is currently underway, and crews are coming out of the Varty Stockpile site and the Smith Aggregate Pit.

**Surfaced Roads**

Asphalt repairs began Monday, August 27<sup>th</sup> which includes some culvert replacement locations, bridge transitions, and, the Sunchild Road.

Repairs were completed to sections of the Red Deer River Access Road. Anticipate chip seal to be applied the week of September 10<sup>th</sup>.

Crews will continue to inspect and patch any surfaced roads or SB-90 dust suppressions requiring maintenance.

The crack sealing program, on surfaced roads, was completed on Thursday, August 24<sup>th</sup>.

**Maintenance**

Gravel crushing, within Cooper Pit, located at SW 11-37-06-W5M, is scheduled to be completed on September 11<sup>th</sup>, 2018. Once completed in the Cooper Pit, crushing will commence within the Smith Pit, located at NE 31-37-08-W5M.

Condor Lift Station, Phase 2 Upgrades, started the week of August 13<sup>th</sup>, 2018. Upgrades are scheduled to be completed by October 15<sup>th</sup>, 2018.

Construction on BF 70149, located on Range Road 6-0, approximately 6 km south of Caroline (SW 31-35-05-W5M), began on August 16<sup>th</sup>, 2018. Construction is scheduled to last 28 working days.

Construction on BF 13970, located on Township Road 37-3, over the North Raven River (NE 18-37-05-W5M) began on September 4<sup>th</sup>, 2018. Construction is scheduled to be completed by September 29<sup>th</sup>, 2018, weather dependent.

Construction on BF 09970, located on Range Road 6-1 (Bingley Road), over Lobstick Creek (NW 36-40-06-W5M) to begin on September 24<sup>th</sup>, 2018. Construction is scheduled to be completed by October 26<sup>th</sup>, 2018, weather dependant.

Portions to bridge structure BF79392, located west of Highway 761 on the Stauffer Road (SW 16-37-05-W5M), have failed. As such, a temporary Bailey Bridge will be utilized and placed over top of the existing structure, as a temporary measure, so that vehicle movement can continue. Anticipate the bridge structure to be replaced in January 2019.

Annual flushing of the sanitary lines, within the hamlets of Leslieville and Condor, to be completed Monday, September 10<sup>th</sup>. Nordegg sanitary lines to be flushed on Tuesday, September 11<sup>th</sup>.

### **Gravel Road Rehabilitation**

The Shoulder Pull Crew moved Twp. Rd. 37-2, east of SH 761, and has 3000m of the 3500m project completed.

The Re-Hab Crew on Range Road 4-2 has completed project with final clean up underway. Crew will be moving to Twp. Rd. 39-0, east of Everdell Road (Clearwater Estates) sometime this week, weather permitting.

Crew on Range Road 5-5, south of Twp. Rd. 38-4, has completed the 1600m project with final cleanup underway. Twp. 38-4, east of RR 5-5, has also been completed with final cleanup remaining on the 800m project. Crew has moved to Range Road 5-4, south of Twp. Rd. 38-4, and has roughed in 900m of the 1200m project while also roughing in the 1600m project on Twp. Rd. 38-2, west of Range Road 5-4.

### **Base/ Pave Projects**

**Taimi Road** – On the evening of Aug. 31 the Taimi Road project had a fill settlement/ failure on the east slope fill on the north end of the project. The settlement area was barricaded and delineated and monitored throughout the weekend. Pidherney's, WSP and Clearwater County met Tuesday, September 4<sup>th</sup> and discussed causes and mitigation.

The landowner has been contacted and has agreed to sell extra land to accommodate a longer slope proposed to mitigate any further major settlement. Final road grade height has been adjusted to not add further load to the existing structure and additional geotextiles will be used to further strengthen and distribute load throughout the settlement area.

Once road slope has been rebuilt and shaped to meet adjusted design criteria, Public Works is advising monitoring of the fill area for further settlement for a period of time before proceeding with base/pave portion of the project.

### **Nordegg Manufactured Home Park**

PME has completed watermain tie-ins and pressure tested lines. Lines showed 2.5 litre loss, being well under the 24 litre allowable limit. Lines have been chlorinated and will be sampled later in the week. All lot services have been installed with landscaping underway for shallow utilities.

Quarry road east end turn out has been completed and Fortis has staked power poles for installation along Quarry road.

## West Country Road Project

### Northfork Road Phase 2

Netook Construction has completed 3000m of road grade from the south end of the project.

Netook has an additional 500m roughed in and waiting for testing as weather permits.

Netook has another 1000m of road grade being worked and has stripped the rest of right of way on the Northfork Road.
